### Summary of § 6702

Certified Plan-Based Enrollment Program Eligibility Requirements

#### **Exchange Target Populations:**

- Non-Group Members
- COBRA Members
- Members Terminating Individual or Group Coverage, including 25 year-old dependents
- Individuals Interested in Obtaining Health Care Coverage through the Exchange
- Individuals Eligible for Other Insurance Affordability Programs, (e.g. Medi-Cal)



Summary of § 6702

Certified Plan-Based Enrollment Program Eligibility Requirements

Eligible Entities and Individuals:

- Qualified Health Plan Issuers under contract with the Exchange
- Medi-Cal Managed Care Plans
- Customer Service Representatives or Captive Agents Employed by a Certified Plan-Based Enrollment Entity

#### **Outstanding Issue:**

Customer Service Representatives as Plan-Based Enrollers



### Summary of § 6704

**Program Application** 

- An entity or individual who is eligible for the Certified Plan-Based Enrollment program may apply to become a Certified Plan-Based Enrollment Entity or a Certified Plan-Based Enroller by following the process proposed in the regulations.
- The applicant Certified Plan-Based Enrollment Entity and any Certified Plan-Based Enroller included in the application shall submit an executed agreement conforming to the Roles and Responsibilities of the Certified Plan-Based Enroller Program



### Summary of § 6710

Roles & Responsibilities

- Offers at least one QHP in the Individual Exchange
- A Certified Plan-Based Enrollment Entity that is an MMCP, as defined in Section 6100, that does not offer at least one QHP in the Individual Exchange
- Prohibited Activities are defined in this section.

#### Outstanding Issues:

- Cold Calling
- Enrollment in Medi-Cal.
