### **COVERED CALIFORNIA BOARD CLIPS November 21- January 22, 2014**

Since the November 21st Board Meeting, the high visibility media issues included: the announcement of the November and December enrollment numbers; Covered California choosing not to extend the payment deadline; thousands of consumer names and information being released to insurance agents; the unveiling of the LGBTQ ads and billboards to consumers; the misleading Obamacare website created as a resource guide for Californians; the Covered California board voting not to extend the canceled health plans; the weekly release of numbers and data regarding the website and applications; and general coverage and opinions on Covered California and the Affordable Care Act.
