Re: Affordability Subsidies for Covered California Enrollees

Dear Secretary Ghaly, Dr. Hernandez, Mr. Barrios, Ms. Kendell, and Mr. Fleming:

Our organizations strongly support the action taken by the Covered California Board of Directors at its June 2022 meeting to provide additional cost sharing subsidies to Covered California enrollees if the federal government extends the federal premium subsidies originally provided through the American Rescue Plan.

The recently passed and soon to be enacted federal Inflation Reduction Act will extend the additional premium subsidies for three years, providing millions of Californians with lower subsidies. Most of your enrollees will now pay premiums of less than \$10 per month—and many will have zero premiums thanks to the combination of state and federal actions.

Because of the foresight of Governor Newsom, the California Legislature and Covered California's Board and staff, the 2022-2023 state budget not only provides \$304 million in affordability help but makes clear that when the enhanced federal premium subsidies are extended, the state subsidy funding will be used to lower cost sharing, including:

- Zero deductibles for every consumer who selects a silver plan, eliminating deductibles of as much as \$4,750 for many enrollees and \$75 for the lowest income who have federal cost sharing reductions.
- Lower copays for many services for the standard silver plan:
 - \$30 for a primary care visit instead of \$45
 - \$10 for generic drugs instead of \$16
 - \$40 for preferred brand name drugs instead of \$55

California pioneered state-level premium subsidies that laid the groundwork for enhanced federal premium subsidies.

You now have the opportunity to offer zero deductibles to every consumer earning under 600% of the federal poverty level in a silver plan and to lower copays for more than half of your enrollees. We strongly encourage you to take action to re-affirm the action taken in the June 2022 board meeting "to approve and adopt the 2023 Program Design."
